It consists of a total of 28 digits, based on 25 codes included in 20 variables organised into 4 decision clusters, yielding 2 diagnoses.

It is based on Pilowsky, Levine and Boulton's paper on "The classification of depression by numerical taxonomy," published in the *British Journal of Psychiatry* in 1969 in which, with the employment of numerical taxonomy, class A or neurotic depression and class B or endogenous depression, is separated within a group of mixed psychiatric patients. In revised CODE-DD class A or neurotic depression is characterised by depressed mood, lack of interest, loss of desire to live (suicidal tendencies), feeling of inadequacy, impairment of social adaptation, irritability, hypochondriasis, worse in the evening and feeling of guilt (self-incrimination, or suspiciousness); and class B or endogenous depression by depressed mood, motor retardation (retarded thinking or stupor), decreased sex drive, decreased appetite, insomnia, somatic symptoms (vegetative manifestations), disturbance of concentration, apathetic indifference and feeling of hopelessness.
